**DESIST AND REFRAIN ORDER**  
**(For violations of sections 17200, 17210.2 and 17403 of the California Financial Code)**

The California Corporations Commissioner finds that:

1. Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express Ltd., and Ellie J. Jenkins have engaged in the business of an escrow agent by advertising escrow services over the internet at [www.express-ship-tour.com](http://www.express-ship-tour.com) from 2000 to the present as follows:

a) ECommerce Trade represents on its website at [www.express-ship-tour.com](http://www.express-ship-tour.com) that the process works as follows: The buyer and seller agree to the terms of the transaction. The buyer pays eCommerce Trade, which verifies the payment. eCommerce Trade notifies the seller to ship its merchandise and then verifies that the buyer receives the shipment. The buyer accepts the goods. eCommerce Trade then pays the seller and the transaction is complete.

1                   b) ECommerce Trade claims to protect both the buyer and the seller from fraud with  
2 this process.

3                   c) Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express  
4 Ltd., and Ellie J. Jenkins have represented that the escrow services provided by eCommerce Trade at  
5 the Express-ship-tour.com website are provided by Internet Escrow Services (IES), and that the  
6 service is “fully licensed and accredited as an escrow company and is subject to compliance with all  
7 applicable escrow regulations.” In fact, IES is an affiliate of Escrow.com and eCommerce Trade is  
8 not affiliated with either IES or Escrow.com.

9                   d) Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express  
10 Ltd., and Ellie J. Jenkins have represented that eCommerce Trade holds escrow license number 963-  
11 1167. In fact, California escrow license number 963-1167 was issued to Escrow Services of the  
12 Central Coast, Inc. The license was suspended on April 5, 1996, and surrendered on May 20, 1996.

13  
14                   2. Neither Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express  
15 Ltd., nor Ellie J. Jenkins has been issued a license from the Commissioner authorizing them to  
16 conduct business as an escrow agent, as required by California Financial Code section 17200.

17  
18                   3. Neither Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express  
19 Ltd., nor Ellie J. Jenkins is exempt from the licensing requirements of Section 17200.

20  
21                   4. Neither Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express  
22 Ltd., nor Ellie J. Jenkins has been issued a license from the Commissioner authorizing them to use  
23 words indicating that they are in the escrow business, as required by California Financial Code  
24 section 17403.

25  
26                   5. Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express Ltd.,  
27 and Ellie J. Jenkins have disseminated or caused to be disseminated false, misleading and/or  
28 deceptive statements or representations which refer to eCommerce Trade’s affiliation with IES,

1 when, in fact, eCommerce Trade is not affiliated with IES in any way.  
2

3 Based upon the foregoing findings, the California Corporations Commissioner is of the opinion that  
4 Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express Ltd., and Ellie J.  
5 Jenkins and their officers directors, partners, agents, employees and/or servants are in violation of  
6 California Financial Code sections 17200, 17210.2(a) and 17403(a). Pursuant to California Financial  
7 Code section 17416, Express-ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar  
8 Express Ltd., and Ellie J. Jenkins are hereby ordered to desist and refrain from engaging in the  
9 business of receiving escrows for deposit or delivery without first obtaining a license from the  
10 Commissioner. Pursuant to California Financial Code section 17403(b), Express-ship-tour.com,  
11 eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express Ltd., and Ellie J. Jenkins are further  
12 ordered to immediately desist and refrain from issuing, circulating, or publishing any advertisement  
13 by means of any communication, including any website, or making use of or circulating any  
14 letterheads, billheads, blank notes, blank receipts, blank escrow instructions, certificates, circulars, or  
15 any written or printed paper containing any fictitious or corporate name or other words indicating that  
16 they are in the escrow business. Pursuant to California Financial Code section 17210.2(c), Express-  
17 ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express Ltd., and Ellie J. Jenkins  
18 are further ordered to immediately desist and refrain from disseminating, or causing or permitting to  
19 be disseminated, in any manner whatsoever, any statement or representation which is false,  
20 misleading, or deceptive, or which omits to state material information, or which refers to the  
21 supervision of that agent by the State of California or any department or official thereof. Express-  
22 ship-tour.com, eCommerce Trade, SkyStar Escrow Ltd., SkyStar Express Ltd., and Ellie J. Jenkins  
23 are further ordered to immediately desist and refrain from disseminating or causing or permitting to  
24 be disseminated, in any manner whatsoever, any statement or representation that eCommerce Trade is  
25 in any manner associated with IES.

27 This Order is necessary, in the public interest, for the protection of investors and consistent with the  
28 purposes, policies and provisions of the California Escrow Law. This order shall remain in full force

1 and effect until further order of the California Corporations Commissioner.
