Based on the findings contained in the Statement and the Citation, the Commissioner has determined that an order should be issued pursuant to Corporations Code section 31115(a) denying the effectiveness of the franchise renewal registration submitted by Persona Pizza Holdings LLC.

NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that effectiveness of the franchise renewal registration submitted by Persona Pizza Holdings LLC is denied. The issuance of this order is necessary, in the public interest, for the protection of investors and is consistent with the purposes, policies, and provisions of the California Franchise Investment Law.
