26 Pursuant to Government Code Section 11522, you are hereby notified that on March 18,  
27 2009, Respondent, Amerigroup Mortgage Corporation (“Amerigroup”) filed a Petition for  
28 Reinstatement of License (“Petition”) with the California Corporations Commissioner

1 (“Commissioner”). A true and correct copy of the Petition is attached hereto and incorporated  
2 herein as Exhibit A.

3 On October 18, 2007, the Commissioner issued an Order to Discontinue Residential  
4 Mortgage Lending and/or Servicing Activities Pursuant to Financial Code section 50319 against  
5 Amerigroup for failing to maintain a surety bond as required under Financial Code section 50205. A  
6 true and correct copy of the Order to Discontinue is attached and incorporated herein as Exhibit B.

7 On December 6, 2007, the Commissioner issued an Order Summarily Revoking Residential  
8 Mortgage Lender and/or Servicer License against Amerigroup for failure to pay its annual  
9 assessment required under Financial Code section 50401. A true and correct copy of the Summary  
10 Revocation Order and underlying Accusation is attached and incorporated herein as Exhibit C.

11 YOU ARE FURTHER NOTIFIED that written argument and/or further written argument,  
12 may be may be presented in this matter and should be received by the Department of Corporations  
13 **on or before June 30, 2009** at its office located at 320 West 4<sup>th</sup> Street, Ste. 750, Los Angeles,  
14 California 90013-1105, attention: Judy L. Hartley, Senior Corporations Counsel.

15 The Commissioner shall render a decision in this matter on or before July 30, 2009.
