20 The California Corporations Commissioner (“Commissioner”) finds:  
21

22 1. Respondent Farm Fresh Ranch Market, Inc. (“Farm Fresh”) is a deferred deposit  
23 transaction originator licensed by the California Corporations Commissioner (“Commissioner”)  
24 pursuant to the California Deferred Deposit Transaction Law (California Financial Code § 23000 et  
25 seq.) (“CDDTL”).

26 2. Pursuant to California Financial Code section 23026, all CDDTL licensees were  
27 required to file an Annual Report on or before March 15, 2007. Pursuant to Financial Code section  
28 23057, all CDDTL licensees were required to file a Survey on or before March 15, 2007. The

1 Annual Report forms, Survey forms and instructions were mailed to all licensees on or about January  
2 5, 2007. On or about March 27, 2007, Farm Fresh was notified by certified mail, return receipt  
3 requested that the annual report and Survey had to be filed no later than the close of business on  
4 April 13, 2007 to avoid revocation of its CDDTL license.

5 3. Farm Fresh has failed to file the Annual Report and Survey in violation of California  
6 Financial Code sections 23026 and 23057.

7 4. Failure to file the Annual Report and Survey is grounds under Financial Code section  
8 23052 for the revocation of a license issued under the CDDTL.

9 5. On June 21, 2007, the Commissioner issued a Notice of Intention to Issue Order  
10 Revoking CDDTL License, Accusation, accompanying documents against Farm Fresh based upon  
11 the above, and Farm Fresh was served with those documents by certified mail, return receipt  
12 requested on July 16, 2007. The Department has received no request for a hearing from Farm Fresh  
13 and the time to request a hearing has expired.

14 NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that the CDDTL  
15 license issued to Farm Fresh is hereby revoked. This order is effective as of the date hereof.
