1 I, CHARLES AGBONKPOLAR, declare as follows:

2 1. I make the following statements based on personal knowledge. If called as a witness, I  
3 could and would competently testify as follows.

4 2. I have been employed by the California Department of Corporations (“Department”)  
5 since 1988. I make this declaration in my official capacity as a DOC employee, and not otherwise.

6 3. Since February 2000, I have been a Corporation Examiner IV, Supervisor, for the  
7 California Finance Lenders Law (“CFL”) (California Financial Code Section 22000 et. seq.). In  
8 this position, I schedule the regulatory examinations for CFL licensees and assign and supervise  
9 the work of the corporation examiners who perform the regulatory examinations. Additionally, I  
10 personally review the examination reports for the major companies holding CFL licenses including  
11 Wells Fargo Home Mortgage, Inc. (“WFHMI”).

12 4. WFHMI currently holds four active licenses issued under the CFL as follows:

- 13 a. License number 603 5658 for WFHMI doing business as Wells Fargo  
14 Mortgage Resources located at 5540 Fermi Court, Carlsbad, California;
- 15 b. License number 605 1436 for WFHMI located at 2730 Shadelands Drive,  
16 Walnut Creek, California;
- 17 c. License number 603 6147 for WFHMI located at 1000 Burnett Ave., Concord,  
18 California;
- 19 d. License number 603 6148 for WFHMI located at 4180 La Jolla Village Drive,  
20 La Jolla, California.

21 5. On or about February 12, 2003, I reviewed the Department’s files to determine the  
22 dates of the CFL regulatory examinations performed for WFHMI licensees since 1988.

23 6. WFHMI has submitted to all regulatory examinations scheduled by the  
24 Commissioner, and responded to all correspondence of the Commissioner concerning these  
25 regulatory examinations.

26 7. In April 2000, the Commissioner conducted a regulatory examination of WFHMI doing  
27 business as Wells Fargo Mortgage Resources, license number 603 5658. Another regulatory  
28 examination at this location was assigned in September 2002 and is still ongoing, under protest.
